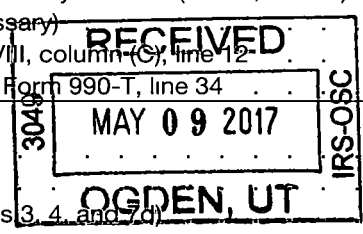

In 2016 we conducted 18 educational events: 7 plenary, 8 specialized, and 3 ecosystem events, each attended by over 50 participants. We gained a pool of 65 potential mentors. We also conducted the "Ignite" program, an immersion boot-camp for Lebanese startups, hosting 2 cohorts of participants in February and August. A total of 5 Lebanese startups attended. We now count a total of 15 Beneficiary Startups. We are working with 8 partner organizations on joint events and mentorship programs. We currently have 526 members and 777 contacts. We have expanded our presence and events to New York City, with San Diego to follow soon. Our new Website was launched in April and our blog was updated regularly, resulting in improved image and branding. We have established an Advisory Board consisting so far of five prominent industry leaders to help us take our programs and initiatives to the next level.
