Our Wholesale Market links small and mid-scale farmers in need of buyers with agencies and other institutions, notably schools, that seek consistent access to locally grown produce. Our goal is to help hard-working farm families (especially beginning farmers, female farmers and farmers of color) make a decent living, while making nutritious, local food available to a broader range of people who want it. In 2016 alone, our Wholesale Market provided over \$200,000 worth of produce to NC residents.

4b (Code:) (Expenses \$ 84,540 including grants of \$) (Revenue \$)

We operate Donation Stations at 38 farmers markets, where volunteers use funds contributed by shoppers to purchase food from farmers, supporting their livelihoods. Farmers help too by donating unsold produce, reducing waste. This food is given to local hunger relief agencies and other organizations supporting vulnerable children and adults. In 2016 alone, our Donation Stations amassed 76,000 pounds of food for local agencies and spent \$45,000 with local farmers, helping them to make a living.

Food Ambassadors provides practical, culturally-appropriate cooking and nutrition education. Trained volunteers visit community sites to demonstrate how to store and prepare fresh produce in ways that are both economical and delicious. In addition to hands-on learning, Food Ambassadors provide fruit and vegetable fact sheets and simple recipes for people to take home. Other Food Ambassador initiatives include Community Meals, where farmers, recipients, and volunteers build community around the table, and Community Food Shares, in which communities form a produce-buying club to promote greater food security.
