ESPWA exists to develop projects that empower the people of Haiti, alleviate poverty, build relationships, and ultimately encourage hope through Christ's love. We operate on a project-by-project basis. During 2016 we were able to support with monetary and people resources both clinics and a hospital, provide sponsorship funds to families, pay for school uniforms, tuition and medical care for 23 children, provide support to a local doctor and a pastor, continued to provide care and nurturing to an agricultural farm used for crops and education, bring immediate help for both cholera and hurricane relief and lastly to encourage the continuing development of a local tourist travel company.
