GRANTS OR SCHOLARSHIPS WILL BE CONSIDERED FOR INDIVIDUALS WHO ARE IN NEED OF FINANCIAL OR ECONOMIC ASSISTANCE, TAX EXEMPT ORGANIZATIONS IN NEED OF FINANCIAL OR ECONOMIC ASSISTANCE, OR INDIVIDUALS WHO HAVE BEEN ACCEPTED INTO A FULLY ACCREDITED COLLEGE OR UNIVERSITY WHO MEET CERTAIN OTHER CRITERIA. PREFERENCE FOR GRANTS IS GIVEN TO PERSONS WHO RESIDE OR PROVIDE THEIR PRIMARY SERVICES WITHIN A FIFTY-MILE RADIUS OF CONEWAGO ENTERPRISES, INC. OR ITS SUBSIDIARIES.
