Successful communities share qualities that make them desirable places to live and work. A fundamental quality of such places is a thriving, sustainable entrepreneurial culture. Guided by this vision, we help regions and communities create entrepreneurial cultures, and encourage and develop business leaders of tomorrow. This has been our goal since inception, and we are the only organization in Indiana executing a strategy that advances entrepreneurs from within Indiana to create a thriving, robust pipeline of growth-oriented companies backed by critical capital and support. 2016 was a record year of capital investment, despite an overall national decline in private equity activity. Elevate portfolio companies span 21 Indiana counties. From 2011 to 2016, Elevate funds under management deployed \$57M in capital, with an additional \$369M generated by co-investments and follow-on investments. For every dollar Elevate invests, other capital partners invest \$6.50, with 1,100 co-investors.
