Through innovation in youth engagement, Youthprise works to authentically engage youth in the design and implementation of programs, policy, systems, philanthropy, and research and evaluation. Grants support innovative strategies developed by and delivered to young people and creative approaches that value youth/adult partnerships and authentic youth engagement. In 2016, we worked with 6 YouthBank sites, an innovative youth philanthropy initiative where groups of youth research community issues and distribute grants to community-based organizations to address them. We also initiated the youth participatory action research network with six organizations who are engaging groups of youth in conducting research and developed action plans to tackle community issues.

Learning and Leadership Youthprise promotes the learning, leadership, and social-emotional development of youth. Programs and initiatives supported in this area expose youth to arts and culture, providing enrichment and youth leadership opportunities. We seek to shift how programs engage youth and support programs that engage youth in leadership and governance, a practice that we model at Youthprise. Young people are embedded across all areas of our organizational work as staff, and half of our 20 member board is between the ages of 16-24. Youthprise brought YouthBank International to the United States and funded 8 YouthBank sites that are centered around youth-driven philanthropy. Youthprise supported 10 Youth Change Fellows with implementation grants to fund their big ideas totaling \$80,000. In 2016 Youthprise invested \$2, 803,991 in Learning and Leadership for grants and strategic investments.

Health and Safety Youthprise supports programs and initiatives that promote the health and safety of young people. In addition to ensuring that basic health needs are met through our Nutrition Program, we take a holistic approach to health and safety and advance intervention strategies that prevent the criminalization of youth, which can pose a threat to public safety. In 2016 Youthprise expanded our Nutrition Program which served 1,500 unduplicated youth with 125,000 meals and snacks at 26 sites. Additionally we support a number of initiatives that seek to reduce disparities in the juvenile justice system and contact between non-violent youth and law enforcement. In 2016 Youthprise invested \$1,056,073 in grants and strategic investments.

Economic Opportunity Youthprise creates opportunities for economic prosperity by supporting programs and initiatives that build workforce skills, promote youth entrepreneurship, and expose youth to career pathways. We work with a range of stakeholders across sectors to equip young people with the economic tools to thrive. Through the Social Innovation Fund, Youthprise selected 6 grantees to receive grants through Opportunity Reboot, a federally funded statewide initiative focused on economic development of young people. As an organization committed to youth entrepreneurship, Youthprise invested directly in 5 young entrepreneurs through YES! Fund grants totaling \$25,000. We formed numerous partnerships to catalyze investments in young people and in 2016 Youthprise successfully leveraged many new commitments in support of Minnesota youth. In 2016 Youthprise invested \$508,614 in Economic Opportunity for grants and strategic investments.

Facts and Circumstances Explanation - for 2016 990Percentage of Financial SupportYouthprise's public support percentage for the 2016 tax year was 29.5%, up from 22.4% in 2015 Sources of SupportYouthprise was created with seed funding from a private foundation and we have been working to diversify our funding base. We have continued to diversify our support through three strategies. 1 Our first strategy is what we refer to as "leveraging," which allows us to secure new resources from public sources by using our existing funding as an incentive for donors to give to Youthprise under the agreement that Youthprise matches these funds and re-grants out to other entities. Over the past two years, we have secured significant amounts of public sector funding through this strategy by partnering with federal, state and county governments. 2 A second development strategy is individual giving that focuses on building a strong development committee on our board, increasing board engagement in fundraising, increasing volunteer opportunities with Youthprise, and implementing a peer to peer fundraising campaign. 3 Third, we solicit major contributions from public and private grantmaking institutions for specific grantmaking and programmatic initiatives. Current sources of public support include governments, private foundations and public charities, and individual donations. Representative governing bodyThe Youthprise board of directors includes a broad cross section of members with experience in corporate, nonprofit and public institutions, as well as youth board members. Availability of Public Facilities or ServicesYouthprise is primarily a grantmaking organization. However, the public is invited to participate in Youthprise activities through a number of mechanisms. We host public events, like Black History Month celebrations and Youthprise Summits. In recent years, an average of 400 people have attended these events. In addition, we sponsor events hosted by our partners and engage with community members, civic leaders, and public officials in a variety of venues. For example, we partnered with a group of concerned citizens referred to as Everybody's In in 2014-2016 to bring together teachers, lay people, clergy, and youth-serving professionals to strategize how to engage the entire community in educating and developing youth. In order to ensure that our grantmaking serves a broad cross-section of the community, requests for proposals and requests for partnerships are distributed widely. We coordinate with the Minnesota Department of Education to conduct our Nutrition Program. The Nutrition Program is offered at 26 sites, including at public sites such as libraries, public housing sites, and recreation centers, and provides meals and snacks to youth in those public venues. In addition, Youthprise has grants or contracts from the following public entities to conduct activities that are viewed as benefitting the public: Ramsey County, Hennepin County, Minnesota Department of Employment and Economic Development, Minnesota Department of Public Safety, Minnesota Department of Education, and Minneapolis Health Department. The Minnesota Legislature passed a bill in May 2016 that has been signed into law by the Governor to provide a new \$1 million grant to Youthprise through the Minnesota Department of Employment and Economic Development.

When accepting a grant, funds are typically designated to serve a geographic area, meet listed conditions, and for a period of time. Grantees agree to use grant funds exclusively for charitable purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the Code). No portion of this grant is earmarked for use in carrying on propaganda or otherwise attempting to influence legislation. Grantees agree not to use any portion of the grant funds to participate in any political campaign on behalf of or in opposition to any candidate for public office, to make grants to individuals on a non-objective basis, or for any non-charitable purpose. In addition, each grantee agrees that it will not promote, support, or engage in terrorism of any kind, nor will it make sub-grants to any entity or individual that engages in these activities. Any unused portion of the grant, or amounts not used for charitable purposes, will be returned to Youthprise. This grant is awarded with the understanding that a report will be submitted to Youthprise describing progress toward outcomes of the grant. Reports cover the use of grant funds (including, without limitations, salaries, travel and supplies) compliance with the terms of the grant, and progress made toward achieving the purpose of the grant. Such reports shall include copies of all press releases and other public announcements of the grant. Installment payment may be withheld in the event of delays in completing the purposes of the grant and/or a breach by the grantee of any of the terms of the Agreement or the grant conditions. The grantee shall maintain financial and other records that specifically show use of grant funds exclusively for the purposes of the grant. A separate bank account for the grant is not required, but it is necessary that a separate accounting of this grant be maintained. Grantees are also required to satisfy grant conditions based on progress toward completion of the deliverables described in the grant conditions. Nongovernmental grantee has submitted to Youthprise a determination letter of tax exemption issued by the Internal Revenue Service that states the grantee is tax exempt under Section 501(c)(3), and is not a private foundation as defined in Section 509(a) of the Code. The grantee further states that its determination letter is still valid and the organization's tax exempt status has not been revoked. The grantee is required to provide in writing to Youthprise within 10 days of receiving notice of any changes to its tax exempt status, including private foundation status under Section 509(a). In the event the grantee has failed to comply with the terms of the Agreement or if its tax-exempt status is revoked by the Internal Revenue Service, the grantee, upon written notice from Youthprise, shall immediately return all unexpended grant funds to Youthprise and Youthprise may terminate the Agreement.
