In conjunction with the Longshore Men's Golf Association the Friends accepted contributions for the redesign of Longshore Park, an important Town amenity purchased in 1960 upon the bankruptcy of a private country club. The park provides swimming, tennis, golf, playground and other recreational facilities for residents of Westport and surrounding communities. A portion of one parking lot has experienced periodic storm flooding and a building that houses rest rooms, locker rooms and a shop requires major repair. Following the Friends' success in 2012 with raising funds for a storm shelter, rest room and refreshment stand for the golf course, the LMGA has begun work on a redesign of the parking lot, building and driving range. The Friends served as a fiscal sponsor for the LMGA which raised private contributions for the project in lieu of seeking fiscal appropriations by the Town. In 2016 the focus of the LMGA fundraiser was to raise funds for the replacement of the clubhouse. The clubhouse has been deteriorating with roof leaks, plumbing problems, and other issues requiring expensive repairs. The LMGA would like to expand the clubhouse into a community facility that has an area where visitors can congregate, have breakfast, buy drinks and snacks, and have meetings.

Wakeman Town Farms is an educational farm that provides training in horticulture, nutrition, animal husbandry, and environmental science. WTF operates on land and from buildings contributed by the Town under a long term lease arrangement. Classes are held for school children and adults. Agricultural produce is delivered to the Town's shelter for homeless residents, the Gillespie Center. The building that houses classrooms as well as the WTF's caretakers needed to be rebuilt and expanded; among other things, lead paint was believed to be present. The project was completed in 2016. In 2016 WTF began a fundraising campaign to build "Tim's Kitchen," a new and refurbished room in the main farmhouse which would house programs for parents and children on issues of concern to our Town, such as environmental conservation, healthy food cultivation and preservation, and drug prevention and addiction.

The Friends began development on the Arbor Program, a project to plant trees with private donations in parks and along park roads. In 2015 the Friends prepared a plan and worked with the Tree Warden and the Director of Parks and Recreation to develop procedures for determining tree replacement and pricing for both planting and maintenance. Final approval was granted by the Parks and Recreation Commission in the Spring of 2017. A website was built with a GPS locator that allows the Tree Warden to designate where to plant specimen trees and donors to choose where they would like their contributions to go. No trees were donated or planted in 2016.

Since 2011, as the Friends have started their activities, income has been insufficient to meet the cost of web site development (\$1,500 to date) and Directors and Officer's Liability Insurance (\$1,900 per year). Mr. Mayer and Mr. Stein made interest free loans to the Friends to meet these obligations. In 2015 the Friends developed a new project, known as the Arbor Program, which will invite citizens to plant trees around Town. The Friends will earn a minimum of \$100 per tree (or 5% of the total cost of the tree, if higher) as a fee to defray its expenses. The Friends expect that at least 10 trees can be planted each year. Together with its administrative fee of \$500 to each beneficiary that seeks help from the Friends the Board believes that income will soon meet expenses and the loans can be repaid.
