The discussions include comparable salaries of executive directors at other nonprofits in the area and cost of living adjustments. It is then proposed to the entire board for approval. The board is made up of independent individuals and, hence, their approval is considered appropriate for the organization. If a change to the executive director's annual salary is made, it is contemporaneously documented in the board minutes for that year.
