It gathered more than 13,000 of the world's foremost experts, activists and implementers from 155 countries. AIDS 2016 marked not only the passing of three decades since the first International AIDS Conference (held in Atlanta, United States, in 1985), but also a return to South Africa, specifically to Durban. AIDS 2016 was the place for the leaders of the global HIV response to forge critical plans and hear the voices of those most impacted—people living with HIV and those at risk of acquiring HIV. The conference linked science with policy and activism, encouraging partnerships to produce the mix of efforts needed to achieve success. With the largest scholarship programme in conference history, AIDS 2016 brought together a record 940 scholars from 105 countries to contribute their expertise and learn alongside the world's top experts.
