In accordance with the mission of this organization, Ukraine Partnership Foundation (UPF), all grants on pages 1 and 3 are to, or for the benefit of, the Ukraine Baptist Theological Seminary (UBTS). UBTS is a Baptist seminary that is located in Lviv, Ukraine. UBTS is registered in LVIV and the Ukraine as a religious organization. The seminary had approximately 400 students in 2016.

The financial support provided by the Ukraine Partnership Foundation to UBTS is monitored in the following ways:

1) The Board of Directors of UPF determines the financial support that UBTS will receive and the purposes for which the funds will be expended.

2) UPF periodically receives a budget and financial statements from UBTS.

3) A third party audit is conducted on UBTS.

4) The President of UPF, Wilbur J. Privott, works on a continual basis with the President of UBTS, Yaroslav Pyzh, to ascertain that the financial support that is provided is used for purposes within the mission of UPF. This includes ongoing conversations regarding the management, direction and long term objectives of the seminary.

5) The President of UPF physically visits UBTS in the Ukraine at least twice yearly to work with UBTS and to review progress.

Similarly, several volunteers associated with UPF make numerous trips to UBTS and report back to UPF.
