<p>28 New Farmer Training The Seed Farm's new farmer training program provided over 600 hours of intensive training to each of four beginning farmers. Most new farmers who come from non-farming backgrounds lack vital knowledge and training in many skills that are critical for long-term farming success. Over the course of a farming season (approximately eight months), The Seed Farm's training program provided new farmers with a combination of hands-on experience and classroom instruction on farm management skills in production, marketing, business planning, equipment operation, and more. Training program success is measured by improvement in 75 percent of 122 knowledge and skill areas that we have identified as critical to new farmer success. In 2016, trainees showed improvement in 88, or 72.6 percent, of these critical skill areas. In addition to providing intensive, full-season training, The Seed Farm partnered with organizations such as Penn State Cooperative Extension, the Northeast Incubator Farm Training Initiative, Pennsylvania Association for Sustainable Agriculture, and PA FarmLink, to provide training in workshop and short course formats.
