International Peace and Dialogue program engages directly with foreign leaders, governments and regimes. North Korea Project: The purpose of this project is to break through the ongoing tension over nuclear weapons and establish more stable relations between the Democratic People's Republic of Korea (DPRK) and the International Community. In 2016, RCGE visited DPRK to help negotiate the release of American student, the recovery and return of remains of US servicemen, and humanitarian relief work in the flood affected areas. Cuba Project: The purpose of this project is to jump start relations between the governments of Cuba and the United States. In 2016, RCGE facilitated two exchange delegations of young elected officials between Cuba and the U.S. These were bipartisan groups. Capacity Building Training and Education to Governments in Transition: In 2016, RCGE trained political candidates in Myanmar in the aftermath of the historic elections. The Center also led a Partnership Opportunity Delegation to Myanmar, bringing together social enterprises and investors to help in the emerging technology sector in the country. The Center also conducted its third installment of Middle East Generational Ambassadors Program. The program brought together 12 social entrepreneurs from Turkey, Israel and Egypt, to a week of training in Boston, as a way to establish cross-border bonds. Negotiating for Release of Detainees: RCGE has past experience and established protocols for negotiating for the humanitarian release of detained individuals, whether held by regimes or criminal organizations. In 2016, RCGE was successfully involved in the release of a Maryland woman from Gambia, and engaged in the efforts to release Otto Warmbier from DPRK, Joshua Holt from Venezuela, 3 Israelis from Gaza, and Joshua French from the DRC. Providing Institutional Advice and Support to Countries as a Non-Government Organization: RCGE looks to provide support to countries looking to develop and implement policies to protect their environment, wildlife and material resources, and securing and delivering humanitarian aid to vulnerable populations in countries affected by war, disaster, or environmental degradation.

Establishing Wildlife Program in Africa: RCGE launched a program during 2013 to assist and boost efforts aimed at securing a safe and secure future for threatened African populations. Working in partnership with African parks, RCGE supported a poacher to protector amnesty and rancher training in the Republic of Congo and continues support for a permanent training facility. The Center developed a curriculum for Asset Forfeiture Regime training, issued two independent newsletters, and followed through the Poacher-to-Protector pilot initiated the year before. In 2016, RCGE conducted an assets forfeiture training module in Kenya, training representatives from 6 African nations. In addition, RCGE partnered with HSUS to assist with securing the care for 60 recovering chimpanzees in Liberia.
