2016 DreamPower Foundation Accomplishments DreamPower Foundation provided equine-assisted activities and therapies to 734 individuals ages 3-86 through 20 unique program during 2016. DreamPower launched six new therapeutic programs in 2016: the Therapeutic Carriage Driving Program (DreamPower Hitch Team), LEOS Youth groups for children from law enforcement families, the LEOS Law Enforcement Couples Day at the Ranch, Equine Empowerment for Elders (for elders with high-functioning dementia), the Horse Happy Hour (an after-work recreational program for adults wanting to learn more about horses) and the Therapy Dog Certification Class in partnership with Operation Freedom Paws. DreamPower expanded partnerships serving the San Jose Police Department and Learning Services (serving adults with traumatic brain injuries). Four new therapy horses came to DreamPower in 2016. DreamPower won first place in a nationwide online voting contest to win a Gypsy Vanner therapy horse. Because we won first place in the contest, we chose LexLins Patriot, a 5-year-old Gypsy Vanner gelding donated by Lexlin Gypsy Ranch in Tennessee. We did have to raise the funds to transport Patriot from Tennessee to California and to build him a new stall. Scooter is a Gypsy Vanner gelding donated by Jeanette Durst for the Horses for Warriors veterans program. K C and Flash are retired national champion Morgan carriage driving competition horses that were donated to the new Therapeutic Carriage Driving Program by Debbi and Stan Packard at the Clay Station Horse Park. Five new masters level psychotherapist interns joined the DreamPower staff as volunteer therapists in 2016. The DreamPower staff consists of a licensed psychologist, four Licensed Marriage and Family Therapists, 8 Marriage and Family Therapist Interns, and 4 PATH Intl Registered Therapeutic Riding Instructors and 10 PATH Intl Equine Specialists in Mental Health and Learning. Many improvements were made to the ranch in 2016, including the purchase of our first (used) tractor and a shelter to store it in. We also built a new tack shed for the driving harnesses and equipment and put up a storage tent to store all the carts and carriages for the therapeutic carriage driving program. On April 23 DreamPower hosted the first LEOS Project Law Enforcement Couples Day at the Ranch. Also in April the Eco-Education Trail Sign project was completed. In April DreamPower staff taught a class for John F Kennedy University on Equine Therapy and the Expressive Arts. On June, 7 DreamPower staff presented workshops at the Professional Association of Therapeutic Horsemanship International Region 11 Conference. Also in June, DreamPower hosted the Ninth Annual Camp for Children with Special Needs. On July 5 our new horse Patriot arrived at DreamPower from Tennessee. On July 17 the DreamPower miniature horses were featured at the Morgan Hill Community Picnic and on July 23 they were featured at the Sunnyvale Elks/Dept of Public Safety Day at the Ranch for children on the autism spectrum. On July 30 DreamPower celebrated six years of serving U S military veterans and on Aug 1 DreamPower was 14 years old! In August the first LEOS Youth group began for children from law enforcement families and the first Advanced Therapy Dog class was certified by DreamPower and Operation Freedom Paws. Also in August, Martha McNeil presented a national webinar on therapeutic horsemanship on equestrianprofessional.com. In October DreamPower hosted a PATH Intl Equine Specialist in Mental Health and Learning workshop and certification and the second LEOS Youth group began. On Oct 22 DreamPower hosted the Fourth Law Enforcement Family Day at the Ranch. On Nov 7 the Autism Research Group completed two years of research on the social and emotional benefits of group equine facilitated psychotherapy for children on the autism spectrum. In November Martha McNeil taught a masters level class for John F Kennedy University on the Theoretical Foundations of Equine Facilitated Psychotherapy. Also in November, Scooter, K C, and Flash all joined the DreamPower therapy herd. On December 23, the miniature horses went to visit adults with traumatic brain injuries at Learning Services.
