ASSOCIATES DAY PROGRAM The program meets Monday through Friday from 9 00 to 2 30 and is open to adults who have finished high school and are diagnosed with an intellectual and developmental disability After high school, the state does not provide programs for adults with IDD Our program fills this gap The adults who attend the day program attend classes to improve their academic skills, participate in field trips and community activities, complete activities to increase daily living skills, have the option to work for pay in our thrift shop and develop life-long friendships by playing and laughing together The program currently serves thirty adults

THRIFT SHOP The Soaring Eagle Thrift Shop fulfills three purposes for our program 1) provides a place for associates who want to work -- they work one hour a week and are paid minimum wage, 2) provides a place for learning prevocational skills in a real life, retail setting, and 3) provides an opportunity for associates to participate in the community through their relationships with our customers

SOCIAL AND ATHLETIC PROGRAMS We sponsor year round formal and informal social activities which are open to any adult with an intellectual disability and their family members There is no charge for our social events which include such events as parties, dances, swimming, cookouts, movies, Wii bowling tournament, game night The average attendance is 50 adults and their families with over 120 attending our Holiday Dance and Dinner We also offer sports (bowling, basketball, softball) to any adult with an intellectual disability We charge a nominal fee with scholarships available for anyone who cannot afford the fee We hold weekly practices and participate in Special Olympics tournaments Twenty adults participate in our athletic program
