The funds have been loaned to individual homebuyers and developers to acquire, renovate and sell 197 formerly vacant and/or foreclosed homes in neighborhoods targeted by HUD. Funds earned will be recycled into the project.

 Program Services - HNI brings funding and services to support the improvement of 41 "middle" neighborhoods in Baltimore City. The resources include below market loans for purchase and home renovation, operating and marketing support for neighborhood organizations, free design advice for rehabbers and partnerships with neighborhood schools.
