The coalition provides colon cancer education and screening efforts in 25+ states around the country through over 40 walk/run/bike events annually. Funding is directed to the creation and continuation of colorectal screening programs for the under and uninsured in local event communities, the largest being Philadelphia, Minneapolis, Boston and Charlotte. Nationally the coalition works to remove barriers to colorectal screening, driving the effort to early intervention and detection of colon cancer. The organization also continues to work with patients and survivors to provide education and support.
