This includes basic introduction to the game through its support of the Colorado Golf Association and CO Section of the PGA's Golf in Schools Program, to identifying, supporting and promoting the most dedicated and talented players through the Hale Irwin Elite Player Program run by the Colorado Golf Association. More than 8,000 students received instruction in 2016 through golf in schools and 14 players participated in the Elite Player Program.

See Schedule O Community Partnerships The Foundation supports programs and organizations who wish to introduce golf to those who may not otherwise have the opportunity to experience all this great game has to offer. Through community partnerships the Foundation creates an environment where kids have fun while developing skills that build self-esteem and reinforce ideals like honesty and fair play. In 2016 funding from the Foundation helped support partnerships serving more than 300 kids with the Colorado Golf Association, Cherry Creek & Aurora Special Olympics (75 Participants), Big Brothers/Big Sisters (180 Participants), Aurora Veterans Home (10 Participants), Boy Scouts of Colorado (28 Scouts), Semper Fi Fund (16 Adults).

See Schedule O Caddie Programs The Foundation believes that caddying instills the life skills and quality of character that build self-reliance in young people. The Foundation is achieving this through its support of the Solich Caddie & Leadership Academy, the annual Caddie Summit and grants to other caddie programs throughout the state. Participants in the Academy have a financial need with Household Income between 60-80% of Denver Area Median Income. 111 students, ages 14-15, have completed one year in the Academy and 86 students have completed the full two-year program. 13 students have gone on to receive the Evans Scholarship for Caddies at the University of Colorado.
