Adult Day Services- Easter Seals TriState's Adult Day Service and Therapeutic Social Recreation programs help senior and non-senior adults with disabilities remain in the community and enjoy their non-working day. Day services at one of our three locations include physical exercise, social interaction, mental stimulation, and an individual plan of care. Veteran Services- Easter Seals TriState's veteran services include Academics for Excellence and Operation Vets THRIVE that help veterans successfully transition from military to civilian life. Services include the Community OneSource phone line (1-513-878-2200) that veterans can call to access community services such as emergency food, shelter, health services, financial assistance, and help accessing military benefits. Employment services for veterans include resume and job search assistance, interview skills, and learning how to translate military experience into terms civilian hiring managers understand. Other- Easter Seals TriState assists older adults and persons with disabilities through the Home Choice program to move from institutional services and support systems to home and community-based settings. Easter Seals TriState is part of a community-wide effort to address health disparities for individuals with disabilities. Exercise and nutrition classes, medical screenings, and educational programs encourage a healthy lifestyle for a population that has historically under-utilized community health services.
