Food Pantry: Clients must show proof of residency in Fairborn or Bath Township. The pantry is open twice a week. Money and food are received through personal donations, organizations, and the Food Bank of Dayton. There were 7675 families served in 2016. These families consisted of 8620 children, 12362 adults and 4609 senior citizens for a total of 25591 individuals. All families received enough food for a minimum of 9 meals. Families may come to the pantry twice a month. Exceptions may be made by the screening staff.

Financial Aid: Clients with shut-off notices for utilities or eviction notices can receive a small amount of money (not to exceed \$100 per year) to help pay their bill. One night of emergency lodging is sometimes provided for a homeless client(s). Financial aid was given to 452 clients.
