Preserve WV AmeriCorps program is a statewide service initiative to promote community revitalization through historic preservation. In 2016, PAWV deployed 38 AmeriCorps members throughout the state to nonprofit organizations and local government agencies for one-year service terms. During their service, AmeriCorps members completed historic preservation projects and managed and recruited volunteers. AmeriCorps service projects include planning and implementing heritage-based events, preservig historical resources, and coordinating and providing educational programs to the public.

PAWV's Field Services program is a statewide program in which staff travel to historic sites to provide technical assistance to individuals and organizations trying to preserve and use historic resources. The major initiative through this program is the West Virginia Endangered Properties program.

PAWV's statewide historic preservation conference is held biennially at a different location each year. In 2016, the conference was held in Beverly, West Virginia over a three-day period in September. The annual awards banquet took place during the conference. During this event, PAWV provides participants with educational concurrent sessions, tours of the host county, keynote speeches, and hands-on workshops. There were approximately 175 participants at the event. Three grants were given during the annual awards banquet. There were three recipients of \$500 grants: the Monroe County Historical Society, the Greenbrier County Historical Society, and the Williamsburg District Historical Foundation.
