THESE PROGRAMS INCLUDE CREDIT ENHANCEMENT PROGRAMS, GRANTS, AND URBAN AND RURAL LENDING. SEVERAL OF THE CREDIT ENHANCEMENT PROGRAMS INCLUDE THE LINKED DEPOSIT FUND AND THE CHILD CARE CAPITAL FUND. All board, staff, and volunteers sign statements to affirm that they have read such policies and understand them. All corporate policies are reviewed on an annual basis by key staff. Recommendations for policy changes are brought before the board for review and approval. Policy changes are communicated to board, staff, and volunteers. The executive committee is charged with the responsibility to regularly and consistently monitor and enforce compliance with the conflict of interest policy by reviewing annual statements and taking such other actions as are necessary for effective oversight.
