through the Donation and Transplantation Grant Program to support innovation and also its support of educational programming through grants issued to schools and houses of worship, and scholarships In addition to the program expenses supporting these initiatives, Transplant Foundation extended support through a grant for the on-going operation of Gift of Life Family House Gift of Life Institute Transplant Foundation fulfills its mission to provide professional education and training through its education and research division, the Gift of Life Institute Transplant Foundation, through its Institute, seeks to advance the science, safety and efficiency of the donation process Transplant Foundation focuses on these objectives because the supply of organs and tissues for transplantation continues to fall short of expectation Currently, there are over 118,980 persons awaiting a life-saving organ transplant in the United States and thousands of others who could benefit from life-enhancing tissue transplants In calendar year 2016, 5,896 people on the waiting list died while awaiting a life-saving organ transplant Although there is no consensus surrounding a solution to the underlying problem of the organ shortage, training, skill development, education, and retention of donation professionals are major concerns Transplant Foundation's educational programming for professionals is grounded on the philosophy that innovation must replace traditional learning in this field and that historically there has been an unnecessary delay between the acquisition of new knowledge and its implementation through clinical practice Transplant Foundation believes a new approach is necessary to underscore the significance of what is learned, to transmit and disseminate what is known, and to benefit from what is collectively achieved In furtherance of the mission, Transplant Foundation through the Gift of Life Institute conducted sixteen (16) workshops and/or consulting opportunities in 2016, covering family communication and consent for organ and tissue donation, hospital services staff development, with more than 435 professionals participating in those 2016 trainings Additionally, the Institute provided training to 438 donation professionals through its eLearning and virtual classroom initiatives and worked with 10 professionals from four countries to support donation and transplantation initiatives during this time period In total, the Institute has worked with over 39 countries to support the development of responsible and ethical donation and transplantation practices internationally In 2012 Gift of Life Institute expanded its research initiatives and support of transplant recipients when the Transplantation Pregnancy Registry International (TPRI) formerly National Transplant Pregnancy Registry formally joined the Institute Since 1991, TPRI has tracked and studied the outcomes of thousands of pregnancies in solid organ transplant recipients TPRI is an ongoing study, and the information collected helps thousands of transplant recipients make family planning decisions The TPRI team is comprised of nurses experienced in transplant patient care and trained interviewers, some of whom are transplant recipients themselves In 2016, 12 abstracts were submitted to academic meetings and 2 invited book chapters were published Oral and poster presentations were given at academic meetings, transplant centers and recipient support groups In October, 2016, the registry marked its 25th anniversary with an inaugural academic symposium regarding pregnancy during dialysis and after solid organ transplantation and with a celebration with local families who participate in TPRI Transplant Foundation's Donation and Transplantation Grant Program In 2015 the Grant Program was established to advance organ and tissue donation and transplantation in the Gift of Life donation service area The goal of the Grant Program is to support innovation, quality, and safety in the field of donation and transplantation through scientific research, community programming or alternate approaches to existing processes and protocols In 2016 (6) six grant applications were received and over \$60,000 was released in support of the Grant Program Team Philadelphia In 2016, the Foundation continued its sponsorship and coordination, along with Gift of Life Donor Program, of the "Team Philadelphia" entry to the "Transplant Games of America " The Transplant Games are a Special Olympic type program conducted bi-annually for transplant recipients The purpose of the Transplant Games is to increase awareness that transplantation is successful, to increase public awareness and commitment to organ donation by encouraging people to discuss their feelings about organ donation with their families, to recognize the families who donate the organs and tissues from their loved ones each year, and to provide an event that fosters the successful rehabilitation of all patients who have received organ and tissue transplants The athletes act as torchbearers for the more than 118,890 Americans who are waiting to receive transplants, and their second chance at life due to the critical shortage of donated organs for transplant The Transplant Games are also a celebration of life among the recipients, their families, and the families of donors In June, 2016, Team Philadelphia participated in the 2016 Transplant Games held in Cleveland, Ohio Team Philadelphia consisted of over 95 Athletes, 24 Donor Families and over 150 supporters
