Producing Theater - Creative Cauldron produced seven productions  
during 2016. These included three with professional casts and four  
Learning Theater productions featuring young performers. A total of  
121 theatrical performances were presented with 8,767 attendees.  
There were also two performances at a local elementary school reaching  
approximately 1,000 students. The Arts Adventure Camp programs culminated  
with 6 performances attended by 510 patrons.

Educational Arts Programs - Creative Cauldron offered 11 weeks of Arts  
Adventure Camps in the performing and visual arts with 243 children  
ages 4 - 14 participating. Two sessions of the Learning Theater  
Ensemble program were offered culminating in an original performance  
crafted around the young participants. Additional programs include  
Learning Theater Studio, classes, drawing and theatrical design,  
individual piano lessons, acting and improvisation and creative drama.  
A total of 446 students were served by these programs.

Presenting - 33 concerts were presented during our annual Passport  
to the World of Music and Summer Cabaret Series. Guest artists  
represented a wide variety of musical genres and styles. A total of

gallery space was provided for exhibits by members of Falls Church  
Arts. Approximately 2,000 people attended exhibit openings, artist  
receptions and classes.
