In 2016, there were no board decisions that involved any conflicts of interest for the Board to discuss, with the exception of compensation of the Executive Director. The Executive Director is an ex officio, non-voting member of the Board of Directors. The Executive Director recused herself and was not present at any discussions or votes regarding board decisions on the Executive Director's compensation.

When the Executive Director position was created in July, 2014, while the Board did not hire an independent consultant, the Board itself conducted a comparable salary study that looked at Executive Director salaries at comparable organizations in comparable markets and set the Executive Director's salary. Since then they have instituted a 3% annual cost of living adjustment. Annually they have done an evaluation of the Executive Director's performance based on the organizational goals that are aligned with the Board-approved strategic plan for the organization. Based on the evaluation, and the organization's financial position, the board has granted an end of the year bonus for the Executive Director.
