28 In 2016, P4PI launched Celebrate Recovery in Hyderabad, India. Fifteen pastors completed 25 weeks of the Steps Studies and made plans to launch groups in February 2017. Passion 4 People also started the Outreach Specialists Association-South Asia with 5 training groups in India and Nepal. Each training group is composed of 5-20 outreach specialists under one master trainer. P4PI sends a trainer three times a year to teach them how to do creative and compassionate outreach. P4PI also helps them develop in character, family harmony, leadership and community development. In addition to work in India, P4PI helped connect a team to one of our specialists to rebuild a church in Nepal that was destroyed by the earthquake of 2015. P4PI partnered with the Luis Palau Association-Europe to reach youth and adults in Constanta, Romania. Over 1800 people attended 18 events and with 341 completing cards indicating a spiritual decision to trust in Jesus Christ for eternal life and life change. P4PI president, Brad Butcher, conducted classes on personal growth and outreach for several congregations in the Portland area, China and taught at Corban University. Overall, 6169 people attended events directed by P4PI in 2016. Plans for 2017 include starting two new Outreach Specialist groups in India, translating and printing the Foundations Course and Celebrate Recovery Steps Studies into Telugu, Tamil, Nepali and Marathi languages for use by our church partners. P4PI plans to launch Celebrate Recovery in New Delhi, Kathmandu and Latur, India in 2017. In November P4PI is planning to take a team to India for various projects with our team leaders there. We'll also explore the start of a ministry to street women and their children as part of our Celebrate Recovery development. P4PI President, Brad Butcher, will also be assisting Sunrise Church in outreach and training a local group of evangelists, and teaching some sessions at Multnomah and Corban Universities while finishing his Doctoral Project.
