THE MISSION OF THE IAPF IS DIRECT ACTION WILDLIFE CONSERVATION THROUGH ANTI-POACHING RANGER TRAINING, ANTI-POACHING OPERATIONS, CONSERVATION SECURITY PLANS, WILDLIFE CRIME INFORMATION SYSTEMS, AND SPECIAL TECHNOLOGY AND SYSTEMS FOR ANTI-POACHING OPERATIONS. OUR CONSERVATION PROGRAMS SPAN SOME OF THE MOST ECOLOGICALLY SENSITIVE AND UNDERSERVED REGIONS IN SOUTHERN AFRICA. THE ILLEGAL TRAFFICKING OF WILDLIFE IS NOW ONE OF THE WORLD'S LARGEST CRIMINAL INDUSTRIES, WITH REPEATED LINKS TO TERRORISM NETWORKS. HIGH TARGET SPECIES SUCH AS ELEPHANT AND RHINO ARE BEING HUNTED TO EXTINCTION. THESE ANIMALS ARE THE MOST DIFFICULT TO PROTECT AND SAFEGUARDING THEM IS THE CORE BUSINESS OF IAPF.
