PRESERVE In 2016, 2,081 citizen stewards and corps crew members performed the hard, physical labor of annual maintenance and restoration of the PCT. PCTA volunteers contributed 104,269 service hours in 2016, an in-kind value of \$2.46 million. These hours included the completion of 1,997 miles of trail maintenance, 40 miles of trail reconstruction, the construction of two trailhead kiosks and 33 volunteer training events.

PROMOTE Through our print and electronic publications and personal outreach, we promote the PCT, marshal volunteers and keep our members and elected leaders informed of programs and issues facing the trail. In 2016, promotional activities included publishing four issues (54,000 copies) of the Pacific Crest Trail Communicator magazine, and distributing it to members, partners and elected officials, publishing an annual calendar, publishing twelve regular issues of Trail Dirt, the PCTA's electronic newsletter. The PCTA responded to 7,652 inquiries from trail users and the general public, issued 5,657 wilderness permits, and monitored 2,086,591 website visits and 131,869 Facebook likes.
