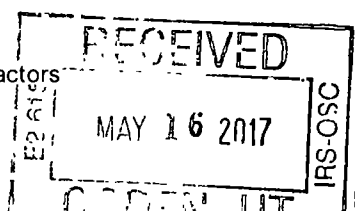



The Foundation provided financial support to many science and engineering non-profit education institutions including the Secondary Science Olympiad of San Diego County to support the San Diego regional science olympiad competitions, the Greater San Diego Science and Engineering Fair to help support the operation of this regional science fair, the Reuben H. Fleet Science Center to support their SciTech program that supports students in traveling to the Fleet Science Center and participating in the exhibits, the Big Brother Big Sisters of San Diego County (Beyond School Walls-STEM) program to support the implementation of a STEM program at a San Diego site, FIRST Robotics of San Diego to support the FIRST robotics competitions in San Diego county, and the San Diego STEAM Maker Festival that is attended by thousands of San Diego area students who experience a wide variety of science and engineering activities. These activities involved thousands of elementary, middle and high school students. The Foundation also judged and provided awards at the Greater San Diego Science and Engineering Fair.

The Foundation, via the General Atomics Scientists and engineers Supporting Science and engineering for Students (GASSSS) program, supported over 70 engineers and scientists to perform science and engineering activities in classrooms or at after school activities or at General Atomics facilities and to reimburse them for science and engineering materials that they purchased and provided to those schools or activities. These activities ranged from giving science and engineering demonstrations to students, assisting teachers with science and engineering lessons, mentoring high school robotics clubs, or providing support to regional science and engineering competitions such as science fairs and science olympiads. On average, each of these activities involved about 50 students, so approximately 3500 students were involved in these science and engineering enrichment activities. All engineering presentations and curricula that were developed by these scientists and engineers were posted on the Foundation web site for others to use. In addition, all of these activities were documented and posted on the Foundation web site so that other scientists and engineers had points of contact and examples of potential activities. During 2016, the Foundation web site (www.sci-ed-ga.org) had 10,457 users who viewed 22,003 pages.
