Provided 17 water projects in North India; Gujarat, West Bengal and Odisha resulting in an estimated impact of 7,000 people. In addition to drilling new bore wells and installing either hand pumps or submersible pump motors and tanks. Additionally provided funding for the support of Lydia's Hostel which cares for 20-25 girls with food, shelter and an post secondary education. Contribution was also made towards a new water system and 2 milk cows to help our north Indian partners with a greater level of sustainability.

4b (Code:) (Expenses \$ 60,670.00 including grants of \$ 44,196.00) (Revenue \$ 3,620.00)

Provided 12 water projects within the state of Andhra Pradesh resulting in an estimated impact of clean water to 5,000 people. In addition to drilling new bore wells and installing either hand pumps or submersible pump motors and tanks, emergency relief water camps were implemented during a period of intense heat in 6 different locations in and around Tuni and Yellamanchilli, AP. Funding assistance also took place so that our partner could implement 6 medical camps and provide monthly assistance to a leper community. Solar panels, lights and fans was also provided to help create a greater level of sustainability for an orphanage.

4c (Code:) (Expenses \$ 75,987.00 including grants of \$ 58,957.00) (Revenue \$ 1,500.00)

Provided 32 water projects in Southern India; Tamil Nadu (13), Telangana (11), Karnataka (8). These water projects were drilled and installed with either a hand pump or submersible pump motor and water tank; the estimated impact is 10,000 people.

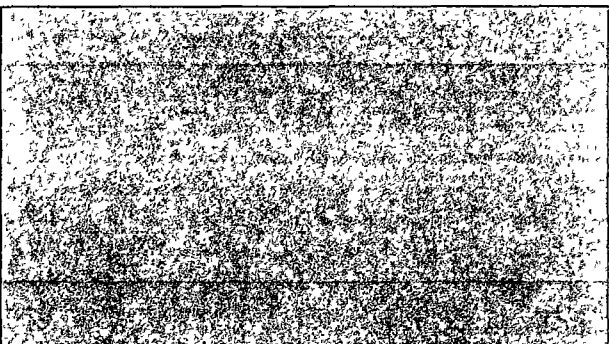
