MARY'S MEALS USA PROVIDES GRANTS TO MARY'S MEALS INTERNATIONAL TO FUND ITS SCHOOL FEEDING PROGRAMS, PROVIDING ONE NUTRITIOUS MEAL EVERY SCHOOL DAY TO VULNERABLE CHILDREN LIVING IN SOME OF THE WORLD'S POOREST COMMUNITIES. THESE MEALS SERVED BY VOLUNTEERS AT SCHOOLS REDUCED HUNGER AMONG CHILDREN, INCREASED SCHOOL ENROLMENT LEVELS, IMPROVED SCHOOL ATTENDANCE AND THE ELIMINATION OF ABSENCES ATTRIBUTED TO HUNGER, REDUCED LEVELS OF CHILDREN DROPPING OUT OF SCHOOL, INCREASED FEELINGS OF HAPPINESS AT SCHOOL AND DECREASED LEVELS OF ANXIETY DUE TO HUNGER. THE RESEARCH OBSERVED INCREASED SUPPORT FOR EDUCATION AMONG VULNERABLE COMMUNITIES. IN 2016, MMUSA'S TWO LARGEST PROGRAM GRANTS SUPPORTED MARY'S MEALS INTERNATIONAL SCHOOL FEEDING PROGRAMS IN MALAWI AND LIBERIA. - CONTINUED ON PAGE 35 DURING 2016, MARY'S MEALS INTERNATIONAL WAS SUPPORTING 1,187,104 CHILDREN IN 12 COUNTRIES. THE MAJORITY ARE LIVING IN SUB-SAHARAN AFRICA, AND OTHERS ARE IN ASIA, LATIN AMERICA AND THE CARIBBEAN. THE LARGEST EXPANSIONS TO OUR PROGRAMS DURING THE YEAR TOOK PLACE IN MALAWI WHERE, DURING 2016, MARY'S MEALS WERE NOW SUPPORTING 880,383 CHILDREN IN 719 PRIMARY SCHOOLS AND 45 UNDER-SIX CENTERS EVERY SCHOOL DAY DURING THE YEAR, MARY'S MEALS INTRODUCED NEW SCHOOLS INTO OUR MALAWI PROGRAMS THROUGH SEVERAL EXPANSION PHASES. THIS INCLUDED THE LARGEST SINGLE EXPANSION MARY'S MEALS HAS EVER UNDERTAKEN WHICH TOOK PLACE WITHIN 69 ADDITIONAL SCHOOLS IN SOUTHERN MALAWI TO INCLUDE OVER 40,000 CHILDREN IN ONE PHASE. MARY'S MEALS WORK WITHIN MALAWI WAS EVEN MORE CRITICAL DURING 2016, AS THE COUNTRY WAS EXPERIENCING ITS WORST FOOD CRISIS FOR MANY YEARS. MORE THAN 6.5 MILLION PEOPLE ARE AFFECTED ACROSS HUGE AREAS OF THE COUNTRY, PARTICULARLY IN SOUTHERN MALAWI. FAMILIES HAVE EVEN GREATER CHALLENGES TO FIND ADEQUATE SUPPLIES OF FOOD FOR THEIR CHILDREN AT THIS TIME AND WE RECEIVED OVERWHELMING SUPPORT FROM LOCAL COMMUNITIES DURING THE EXPANSION PHASES OF OUR PROGRAM. MANY PARENTS TOLD US THAT THE CURRENT FOOD CRISIS IS MAKING A HUGE IMPACT ON THEIR LIVES. THE RESPONSE TO THE CRISIS INCLUDED THE PROVISION OF MEALS IN OUR EARLY CHILDHOOD DEVELOPMENT (ECD) CENTERS DURING THE SUMMER AND CHRISTMAS TERM HOLIDAYS TO ENSURE CONTINUOUS SUPPORT TO THE MOST VULNERABLE CHILDREN IN OUR MALAWI PROGRAM. THIS INTERVENTION RESULTED IN GREAT BENEFITS FOR THE CHILDREN DURING 2016, MARY'S MEALS' LIBERIA WAS PROVIDING SCHOOL MEALS TO 139,811 CHILDREN IN 466 SCHOOLS ACROSS FIVE COUNTIES. MANY OF THE SCHOOLS IN LIBERIA ARE IN REMOTE, HARD TO REACH LOCATIONS DEEP IN THE RAINFOREST AND ARE ONLY ACCESSIBLE BY DIRT ROADS THAT MAKE TRANSPORTATION DIFFICULT, ESPECIALLY DURING THE RAINY SEASONS. IN APRIL 2016, MARY'S MEALS WERE DELIGHTED TO CELEBRATE THE LAUNCH OF OUR SCHOOL FEEDING PROGRAM TO SCHOOLS IN BONG COUNTY. WORKING CLOSELY WITH OUR PARTNERS AND STAKEHOLDERS, OUR PROGRAM IS ALREADY MAKING A HUGE IMPACT. OUR INITIAL RESEARCH AMONG SCHOOLS IN BONG COUNTY FOUND THAT ENROLMENT HAS INCREASED BY 19%. THIS IS A SIGNIFICANT ACHIEVEMENT WITHIN LIBERIA, WHICH HAS THE HIGHEST RECORDED NUMBER OF CHILDREN OUT OF PRIMARY SCHOOL IN THE WORLD IN ORDER TO REDUCE THE NUMBER OF LONG, DIFFICULT JOURNEYS MADE FROM THE CENTRAL OFFICE IN TUBMANBURG, MARY'S MEALS ESTABLISHED THREE NEW AREA OFFICES TO MANAGE OPERATIONS LOCALLY IN THE COUNTIES OF MONTSERRADO, GRAND CAPE MOUNT AND BONG. AREA MANAGERS AND SCHOOL FEEDING MONITORS ARE RELOCATED TO THE RELEVANT AREA OFFICES. THIS HAS ENABLED US TO EFFECTIVELY MAINTAIN REGULAR CONTACT WITH THE SCHOOLS AND IS STRENGTHENING RELATIONSHIPS WITH LOCAL COMMUNITIES.

MARY'S MEALS USA PROVIDES DVDS, BROCHURES AND OTHER MATERIALS TO SUPPORT THESE EFFORTS. REGULAR EMAILS AND LETTERS ARE SENT TO THOSE WHO HAVE REQUESTED UPDATES SO THE INFORMATION CAN BE SHARED IN THEIR COMMUNITIES. SINCE ITS LAUNCH IN APRIL 2016, OUR INSPIRATIONAL FILM, GENERATION HOPE, HAS BEEN VIEWED AT OVER 200 SCREENING THROUGHOUT THE UNITED STATES, ORGANIZED BY SUPPORTERS OF MARY'S MEALS.
