The ECRC promotes the healthy development of young children by strengthening families, improving the quality of early learning experiences, increasing school & community readiness and informing public policy. This is done through a variety of parent education programs, family & children's programming & professional development for people working with children.

The Early Childhood Resource Center (ECRC) is a ministry of the Sisters of Charity Health System. ECRC is dedicated to improving the quality of childcare in Stark and the surrounding counties. This is accomplished by providing training and networking opportunities as well as an extensive resource library to members. The members consist of families with young children, child care staff & community agencies serving families with young children. In 2016 ECRC provided 1,133 hours of professional development training and 2,620 members participated in ECRC's workshops. Thirty three career development training (CDA) classes were provided to childcare workers who are working to attain CDA credentials and 80 childcare workers completed the CDA classes. ECRC maintains a production lab that is available to all members for a nominal annual fee. Members can use the lab to provide educational age appropriate materials & activities for preschool children. In 2016, the production lab was used 2,257 times. ECRC also provides accreditation & support services for home day care providers who wish to enroll in the Step Up to Quality rating system. In 2016 ECRC offered over 500 family programs that focused on literacy, math, music, social studies and science.

The Supporting Partnerships to Assure Ready Kids (SPARK) program is a home-visitation model that focuses on kindergarten readiness. ECRC works with children, families, schools and the community to ensure that their children succeed in school. SPARK engages participating families in structured lesson plans and activities aligned with Ohio's Early Learning and Development Standards, administers developmental assessments and screenings, and initiates referrals to needed community resources. SPARK and schools work collaboratively to ensure that children experience smooth transitions into school. In 2016 over 3,100 children participated in the SPARK program.
