In 2016, ACCESS's Step II transitional shelter served 22 single, homeless adult females over the age of 18. A total of 8,030 bed nights were provided resulting in an average stay of 365 days per resident. 8,760 meals and snacks were served. Step II had 18 graduates in 2016.
