Their mission is to support people with developmental disabilities and their families, to engage in community, and build relationships that enhance their lives as well as the lives of those around them. Annually, the foundation raises funds to support capital improvement projects, new or expanded programs, and personal needs of individuals served. With support from the Foundation, experiences are available to individuals served that cannot be funded with the Medicaid fee payments designed to support basic services. Examples of such experiences include the initiation of an arts program that enables individuals with severe physical limitations to participate in creating paintings, decorative tiles and other pieces. When pieces are sold, the individual who created them earns a commission. Other enhancing experiences funded by the foundation include therapeutic riding and gardening. Individuals served often need help paying for basic necessities such as dental work, clothing, personal care supplies. In addition, Christmas and birthday gifts make it possible for individuals with no family to enjoy these days of celebration. A fund developed by the Foundation helps to support such expenses. Capital improvements to existing facilities and construction of new buildings necessary to fulfillment of the mission are also funded by the foundation. Recent examples include a new vocational center that houses enrichment and employment opportunities for individuals served, and the construction of an indoor riding arena to support therapeutic horseback riding.
