This plan provides an additional benefit based on years of eligible service and vested status and remains subject to a substantial risk of forfeiture.

Part I Line 4b & Part II, Line 2 - Included in Mr. Wood's total W-2 compensation of \$264,569 is \$24,178 which represents the current year payment of deferred compensation from a non-qualified retirement plan which was deferred on prior Form 990's.

Part II Line 1 & 2 - Lorna Strayer and Duane Woods both received their compensation from Fisher-Titus Medical Center, a related organization. This includes compensation for a significant amount of Ms. Strayer's 65 hour average work week and Mr. Wood's 50 hour average work week devoted to the functioning of Fisher-Titus Medical Center as well as uncompensated time devoted to other commonly controlled organizations listed in Schedule R.

Recommendations by the consultant are presented to the Personnel Committee which prepares minutes of its deliberations regarding executive compensation.
