THIS SURVEY INSTRUMENT HAS INFORMATION FROM ORGANIZATIONS WITH SIMILAR BUDGETS, NUMBER OF EMPLOYEES, AND TYPES OF NONPROFITS. BECAUSE OF BVU'S UNIQUE POSITION IN THE NONPROFIT SECTOR, WE HAVE GONE BEYOND THESE MANUALS TO OTHER LIKE ORGANIZATIONS FOR THEIR DATA. SEPARATE MINUTES FOR DELIBERATION ARE MAINTAINED BY BVU'S SECRETARY OF THE BOARD. IN THE FUTURE, THIS PROCESS WILL BE FOLLOWED AGAIN, AND THE FULL EXECUTIVE COMMITTEE WILL ALSO REVIEW THE COMPENSATION RESEARCH. THE ABOVE PROCESS IS USED FOR THE CEO POSITION ONLY. FOR ALL OTHER STAFF POSITIONS, THE CEO CONDUCTS A REVIEW OF EACH POSITION AND MAKES A PROPOSAL FOR STAFF INCREASES TO THE BVU BOARD OF DIRECTORS ANNUALLY.
