PROGRAM LIFE COACHES THE CLEVELAND BROWNS FOUNDATION SUPPORTS THE WORK OF THE LIFE COACHES. THE LIFE COACHES PROGRAM PROVIDES EACH STUDENT WITH A 24/7 MENTOR FOR THE AREAS OF ACADEMICS, BEHAVIOR, ATTENDANCE AND SOCIAL-EMOTIONAL DEVELOPMENT TO SERVE AS A LINK BETWEEN HOME AND SCHOOL. EACH LIFE COACH IS ASSIGNED APPROXIMATELY 25 STUDENTS WHO THEY WORK WITH FROM NINTH GRADE UNTIL THEY GRADUATE. DUE TO THE STRUCTURE AND THEIR SUPPORT, LIFE COACHES HELP IMPACT STUDENT ACHIEVEMENT AND GRADUATION RATES BY HELPING YOUNG MEN REALIZE THE VALUE OF THEIR EDUCATION. RESULTS FROM 2015-16 SCHOOL YEAR INCLUDE A 94% GRADUATION RATE, 80% OF THE GRADUATED STUDENTS PURSUED POST-SECONDARY EDUCATION, 14% ENTERED THE WORKFORCE, 3% ATTENDED TRADE SCHOOLS, AND 3% ENTERED THE MILITARY PROGRAM. ADAPTED FOOTBALL LEAGUE ACHIEVEMENT CENTERS FOR CHILDREN - CLEVELAND BROWNS ADAPTED FOOTBALL LEAGUE WAS CREATED IN 2011 WITH THE GOAL OF GIVING CHILDREN WITH DISABILITIES THE OPPORTUNITY TO PARTICIPATE IN AN ORGANIZED, COMPETITIVE, AND DEVELOPMENTAL SPORT THAT WOULD OTHERWISE BE INACCESSIBLE. THE ACHIEVEMENT CENTERS FOR CHILDREN AIMS TO ENABLE AND EMPOWER CHILDREN WITH DISABILITIES AND THEIR FAMILIES TO GROW, LEARN, PLAY, AND PREPARE FOR LIFELONG ACHIEVEMENT. WITH ASSISTANCE FROM VOLUNTEERS, KIDS ARE ABLE TO BE MEMBERS OF A FOOTBALL TEAM AND PARTICIPATE IN GAME ACTION. THIS PROGRAM IS THE FIRST OF ITS KIND IN THE STATE OF OHIO. THE PRIMARY FOCUS FOR EACH PLAYER EMPHASIZES THREE GOALS: SKILL DEVELOPMENT, SOCIAL INTERACTION AND PHYSICAL EXERCISE. IN 2016, THE PROGRAM INCREASED FROM 104 TO 116 PLAYERS (11.5% INCREASE) AND 177 TO 205 VOLUNTEERS (16% INCREASE). IN ADDITION, THE PROGRAM ADDED 15 PROGRAM AIDES FOR THE FIRST TIME IN 2016 (100% INCREASE) TO SUPPORT PLAYER ONE-ON-ONE SUPPORT, ENCOURAGEMENT, AND SUPERVISION. PROGRAM 2,000 DAYS PLEDGE MORE THAN ANY OTHER STAGE IN LIFE, THE 2,000 DAYS BETWEEN BIRTH AND KINDERGARTEN HAVE THE SINGLE GREATEST EFFECT ON A CHILD'S LIFE AND HAVE A LASTING IMPACT ON LATER SUCCESS IN BOTH SCHOOL AND LIFE. THE 2,000 DAYS PLEDGE IS AN EDUCATIONAL PROMISE BETWEEN TEACHERS AND FAMILIES THAT EMPHASIZES THE IMPORTANCE OF A SHARED PARTNERSHIP AND PROVIDES ONGOING RESOURCES TO FAMILIES TO ENSURE THAT EVERY CHILD IS READY FOR KINDERGARTEN AND ON THE RIGHT PATH FOR CONTINUED EDUCATION. CREATED BY THE CENTERS FOR FAMILIES AND CHILDREN, THE 2,000 DAYS PLEDGE WAS DESIGNED TO CREATE OPPORTUNITIES AND PROVIDE TOOLS FOR ALL PARENTS TO SUPPORT THE SOCIAL, EMOTIONAL AND ACADEMIC DEVELOPMENT OF THEIR CHILD. THEY RECOGNIZE THE BARRIERS THEIR TARGET POPULATION FACES BUT BELIEVE THAT ALL PARENTS CAN FIND MEANINGFUL WAYS TO CHAMPION THEIR CHILD IF THEY HAVE THE RIGHT SUPPORT, TOOLS AND FOLLOW-UP. THE CENTERS WILL BE WORKING WITH UNIVERSITY HOSPITALS TO ARM PEDIATRICIANS WITH THE INFORMATION FAMILIES NEED TO SET THEIR CHILDREN ON THE RIGHT PATH FOR SCHOOL. THE CLEVELAND BROWNS FOUNDATION'S SUPPORT WILL BE FOCUSED ON THIS PARTNERSHIP. IN 2016, THE CENTERS SERVED MORE THAN 4,000 FAMILIES AND 2,400 OF THEM WERE NEW TO THE PROGRAM. IN 2016, THE CENTERS ANTICIPATE MORE THAN 5,000 NEW FAMILIES WILL TAKE THE 2,000 DAYS PLEDGE, THANKS TO A NEW PARTNERSHIP WITH UNIVERSITY HOSPITALS RAINBOW BABIES AND CHILDREN'S HOSPITAL AND SUPPORT FROM CLEVELAND BROWNS FOUNDATION PROGRAM. MARION MOTLEY SCHOLARSHIP THE CLEVELAND BROWNS FOUNDATION AND COLLEGE NOW GREATER CLEVELAND ANNUALLY SEEK TWO DESERVING STUDENTS WHO ARE INTERESTED IN PURSUING A HIGHER EDUCATION TO RECEIVE A \$10,000 SCHOLARSHIP. THE CLEVELAND BROWNS FOUNDATION MARION MOTLEY SCHOLARSHIP WAS NAMED AFTER ONE OF THE BROWNS' 16 PRO FOOTBALL HALL OF FAMERS, FORMER HALFBACK MARION MOTLEY, AND IS TARGETED AT LOW-INCOME, FIRST-GENERATION STUDENTS. SCHOLARSHIP RECIPIENTS ARE RECOGNIZED AT A HOME GAME. CURRENTLY, 92% OF RECIPIENTS ARE ON TRACK TO GRADUATE FROM COLLEGE IN SIX YEARS COMPARED TO 11% NATIONAL AVERAGE FOR LOW-INCOME STUDENTS. IN 2016, 359 STUDENTS APPLIED FOR THE SCHOLARSHIP (31% INCREASE FROM 2015) PROGRAM. KINDERGARTEN CLUB IN PARTNERSHIP WITH THE CUYAHOGA COUNTY PUBLIC LIBRARY (CCPL), KINDERGARTEN PROVIDES AT-RISK CHILDREN WITHOUT PRESCHOOL EXPERIENCE WITH THE SKILLS NEEDED TO BE READY FOR THEIR FIRST YEAR OF SCHOOL. SIMULTANEOUSLY, THE PROGRAM WORKS WITH THE CHILDREN'S CAREGIVERS BY CONNECTING THEM WITH THE NECESSARY INFORMATION AND RESOURCES ABOUT KINDERGARTEN READINESS SO THEY CAN FURTHER THE CHILD'S LEARNING AT HOME. IN 2016, 100 FAMILIES PARTICIPATED IN KINDERGARTEN CLUB, 20 OF THOSE FAMILIES ARE REGISTERED AT THE BROOKLYN BRANCH, WHICH IS SPECIFICALLY FUNDED BY THE FOUNDATION. BASED ON 2014 AND 2015 PARENT SURVEYS, 100% OF PARENT PARTICIPANTS READ ALOUD TO THEIR CHILDREN AT LEAST ONCE A WEEK AND 81% OF PARENT PARTICIPANTS READ ALOUD AT LEAST 3 TO 4 TIMES A WEEK. PROGRAM SPARKLE EFFECT THE SPARKLE EFFECT EMPOWERS TEENS NATIONWIDE TO INCLUDE STUDENTS WITH DISABILITIES IN SCHOOL-BASED CHEERLEADING AND DANCE PROGRAMS. THE PROGRAM FOCUSES ON FOUR PRIMARY GOALS: 1) TO REACH EVERY STUDENT IN AMERICA INTERESTED IN GENERATING AN INCLUSIVE SCHOOL-BASED CHEERLEADER/DANCE TEAM, 2) TO PROVIDE TOOLS, ADVICE AND SUPPORT SO THOSE TEEN LEADERS CAN TRANSFORM THEIR INTEREST INTO VIABLE AND SUSTAINABLE TEAMS, 3) TO CONTINUE SPONSORING OUR ECONOMICALLY-CHALLENGED TEAMS WITH FREE UNIFORMS AND FREE CUSTOMIZED ON-SITE TRAINING, AND 4) TO EDUCATE TEENS, COACHES, TEACHERS, ADMINISTRATORS AND POLICY-MAKERS ABOUT THE IMPORTANCE OF SOCIAL INCLUSION. THE CLEVELAND BROWNS FOUNDATION'S SUPPORT WILL ALLOW THE SPARKLE EFFECT TO IMPLEMENT THIS PROGRAM AT THREE LOCAL SCHOOLS IN NORTHEAST OHIO, DOVER HIGH SCHOOL (14 PARTICIPANTS), NORTH RIDGEVILLE HIGH SCHOOL (12 PARTICIPANTS), LAKEWOOD HIGH SCHOOL (14 PARTICIPANTS), ALONG WITH PROVIDING NEW VARSITY UNIFORMS TO THE INCLUSIVE TEAM, WITH FREE CUSTOMIZED ON-SITE TRAINING TO THE NEW TEAM. AFTER IMPLEMENTATION OF A SPARKLE EFFECT PROGRAM, STUDENTS WITH DISABILITIES THROUGHOUT THE SCHOOL SHOWED AN INCREASE IN SCHOOL ATTENDANCE AND CLASSROOM INVOLVEMENT, AS WELL AS, GREATER CONFIDENCE IN MASTERING CLASSROOM TASKS AND SPEAKING TO ADULT SCHOOL STAFF PROGRAM. INVESTMENT SCHOOL AT WALTON SCHOOL THE CLEVELAND BROWNS FOUNDATION SUPPORTS WALTON SCHOOL AND THE WRAPAROUND STRATEGY BY FUNDING SUPPORT RELATED TO THE LEAD AGENCY AND A SITE COORDINATOR. CLEVELAND STATE UNIVERSITY SERVES AS WALTON'S LEAD AGENCY. THE ROLE OF THE LEAD AGENCY AND THE SITE COORDINATOR IS TO SUPPORT THE IMPLEMENTATION OF AND FACILITATE THE STRATEGY AS ADVOCATES FOR THE SCHOOL AND COMMUNITY. WRAPAROUND STRATEGY INVOLVES THE INTEGRATION OF COMMUNITY SERVICES INTO THE SCHOOL TO HELP SCHOLARS REACH THEIR ACADEMIC GOALS BY REDUCING BARRIERS TO LEARNING SUCH AS HUNGER, UNSTABLE LIVING SITUATIONS AND UNRESOLVED MEDICAL CONDITIONS. WALTON PROVIDES AN EDUCATION THAT ADDRESSES A SCHOLAR'S SOCIAL, EMOTIONAL, PHYSICAL, CULTURAL AND ACADEMIC NEEDS THROUGH AN EMPHASIS ON STUDENT INQUIRY AND GLOBAL PERSPECTIVE. AT THE END OF THE 2015-16 SCHOOL YEAR, WALTON HAD THE SECOND HIGHEST READING AND MATH STUDENT PROFICIENCY SCORES OUT OF ALL TWENTY-THREE INVESTMENT SCHOOLS AND 93.3% OF THIRD GRADERS MET THE THIRD GRADE READING GUARANTEE REQUIREMENTS.
