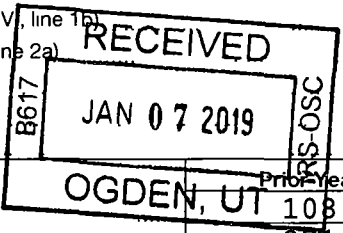

PURPOSEWORKS: THIS PROGRAM IS UNDER REDEVELOPMENT IN AN ONLINE PLATFORM MODEL. STUDENT VOLUNTEERS ARE WORKING TO BUILD UP ITS CAPACITY TO SERVE PEOPLE WORLDWIDE. IT IS DESIGNED AS A PATHWAY FOR ENVISIONING, DEVELOPING, AND LAUNCHING A SOCIAL ENTERPRISE - SOMETHING PURPOSELY CREATED TO ADDRESS A SOCIAL OR ENVIRONMENTAL ILL. WE CONTINUE TO DEVELOP AND TEST MODULES FOR THE PROGRAM AND HOPE TO FUND ITS LAUNCH BY LATE 2017. IT HAS NOT PRODUCED REVENUE, BUT WE HAVE RECEIVED SOME FUNDING FOR ITS CONTINUED DEVELOPMENT.

HATCH COMMUNITY INNOVATION LABS: AS SOCIAL ENTREPRENEURS DEVELOP THEIR BUSINESSES, THEY NEED PLACES TO WORK, LEARN, AND GROW. WE LAUNCHED HATCH COMMUNITY LABS (OR HATCHLABS FOR SHORT) IN LATE 2013 IN PORTLAND TO PROVIDE JUST SUCH AS PLACE - A PLACE FOR CHANGE LEADERS TO CALL HOME. THIS PROGRAM PROVIDES REVENUE FOR EDUCATIONAL PROGRAMS AND COMMUNITY EVENTS AS WELL AS PAYS FOR ITS EXPENSES. BECAUSE OF OUR SUCCESS IN PORTLAND, WE WERE INVITED TO A RURAL TOWN IN NE OREGON TO OPEN A SECOND HATCHLAB IN BAKER CITY. THIS (RE) OPENED IN OCTOBER 2016 ON MAIN STREET. IT HAS DEVELOPED PARTNERSHIPS WITH LEADING AGENCIES THROUGHOUT THE REGION, RECEIVED FUNDING SUPPORT FROM THE USDA AND BUSINESS OREGON, AND HAS FOUR TENANTS. OVER 100 PEOPLE HAVE COME IN SEEKING SERVICES AND ADVICE. MANY NEW PROGRAMS ARE PLANNED FOR 2017.

COMCAP CONFERENCES: COMMUNITY CAPITAL BECAME A PHRASE AND IDEA BECAUSE OF OUR WORK IN OREGON WITH DEVELOPING THE NEW RULES FOR LOCAL INVESTING. THOSE ACROSS THE COUNTRY WHO ARE TRYING TO LEAD THESE KINDS OF EFFORTS ARE LOOKING FOR SUPPORT, EXAMPLES, AND ANSWERS, SO WE LAUNCHED A NATIONAL CONFERENCE TO MEET THAT NEED. COMCAP'16 IS OUR FIRST NATIONAL CONFERENCE, AND WAS HELD IN PORTLAND, OREGON. OVER 350 PEOPLE ATTENDED OVER A THREE-DAY PERIOD, INCLUDING THE GOVERNOR OF THE STATE. WE INTEND TO HOLD THE CONFERENCE IN A DIFFERENT STATE NEXT YEAR, PROBABLY CALIFORNIA. THE OUTCOMES HAVE BEEN FELT HERE LOCALLY AS WELL AS IN STATES ACROSS THE COUNTRY FROM VERMONT TO ALASKA. WE PLAN TO HOLD COMCAP'17 OUTSIDE OF OREGON, LIKELY IN CALIFORNIA.
