There is no automatic right to a bonus or a specific bonus amount even if all criteria are met. The performance measure plan is linked to the Union strategic and fiscal-year business planning process. The plan is intended to focus participants' attention on mission-critical goals and key strategic priorities. The plan is also intended to enhance the performance of Union executives and the organization. Prior to the start of the fiscal year and as part of the business planning process, the Union President and CEO will finalize a list of goals, weights and measures to be used to assess performance during the fiscal year. The list is presented to and discussed with the committee. The committee reviews and approves the bonus plan goals, weights, and measures. Organization goals will be assigned to each participant hospital-wide. In addition to hospital-wide goals individual and/or functional/department goals may or may not be included. After the conclusion of each fiscal year, the President and CEO will prepare an annual Bonus plan report for the committee. The report contains an appraisal of Union and hospital/operating unit performance during the recently-completed fiscal year, and the president and CEO's recommended payout for each plan participant. The bonus recommendations for all sr management are received and reviewed first by the personnel committee who then make decisions and submits to the board to vote. The committee will determine and submit the payout for the President and CEO to the board of directors who, absent the President and CEO, will vote on approval. Award determinations are calculated as percentages of participant's salaries paid for time worked during the fiscal year. Payout for the president is 0% to 30%, CFO and COO are 0% to 25%, and Other executives are 0% to 20%. The executive bonus plan payouts are to be paid when determined by the personnel committee, subject to the approval of the board of directors.
