PRACTICAL HELP IN 2016 INCLUDED \$152,668 IN FINANCIAL ASSISTANCE TO HELP WITH CANCER-RELATED MEDICAL COSTS, 314 INCIDENCES OF TRANSPORTATION ASSISTANCE, 1,261 ITEMS OF MEDICAL EQUIPMENT LOANED, 1,267 WIGS AND HEAD COVERINGS PROVIDED. 1,166 VISITS WERE MADE BY CLIENTS TO ACCESS PERSONAL HEALTH SUPPLIES SUCH AS BANDAGES.
