Management has analyzed the tax positions taken by the Association, and has concluded that as of December 31, 2016 and 2015, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Association is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. As such, the Association is generally exempt from income taxes. However, the Association is required to file Federal Form 990 Return of Association Exempt from Income Tax which is an informational return only.
