Facts And Circumstances Test

Partners in Public Health (PPH) strives to enhance the overall health of the Johnson County community through its programs and services. The WIC Community Garden grows fresh produce for distribution to Kansas WIC (Women, Infants and Children) families. Approximately 2,800 pounds of fresh produce was harvested and distributed to WIC families. The Safe Kids Johnson County Program offered training and education classes on child safety issues to approximately 25,000 people. Members of the PPH Board of Directors have extensive experience in the public health area. There are also members who have long-term volunteer and work experience with the Johnson County Department of Health and Environment programs and Safe Kids coalition. The Treasurer of PPH has more than 30 years' experience in the public health arena and in community programs that impact the overall health of residents. PPH has a continuous program for solicitation of funds through programs and services designed to attract support from individuals, government entities, and other publicly supported organizations. Renewed efforts by Board members are being made to obtain the funding needed for PPH's programs. In addition, the Safe Kids coordinator for Johnson County assists in requesting grant funds to support the activities of the Safe Kids program.
