

Veteran's families for the preservation of a casket flag

Libraries, museums, historical societies, seed exchanges and heirloom seed collectors

Individuals may receive the benefit of preservation in the case of heirloom seeds or specialty plants

Individuals will need to cover the costs of supplies, labor and transportation
