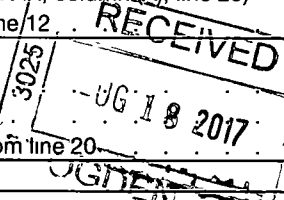

MGS held its 40th consecutive annual conference involving practitioners and researchers from a variety of disciplines, including health and human services providers, academics, higher education students, and older adults. The conference theme was "As We Age: Trends, Triumphs, Transitions". Two keynotes were presented by Andi Egbert, Assistant Director, MN State Demographic Center, and Cathy Wurzer, Morning Edition Host, MN Public Radio News. Ten breakout sessions were held including topics on Advance Care Planning, Brain Health, Preventing Elder Abuse, Homelessness, Long Term Care, Bioethics, Nursing Home Quality of Life, and the MGS Network. The conference was attended by 482.

The annual Gerontologist of the Year award was presented, along with four scholarships awarded to higher education students majoring in a gerontology related field in Minnesota. This conference allows practitioners, researchers, faculty and students to gain information on evidenced-based services to seniors, to learn about relevant research that improve results, and to highlight new new services that meet emerging and critical issues, such as elder abuse. Attendees receive continuing education credits for their participation in the conference.

Education is a primary focus of MGS. To fulfill this mission, thirteen state-wide webinars were held. Topics are selected by a committee of gerontologists and aging service professionals and included: Mindfulness; Depression in Seniors; Older Minnesotan Survey; Living Well - Dying Well; Long Term Care Ombudsman; Addiction in Older Adults; Gerontology and Geriatrics; Caring for Minnesota's Older Population; Advance Care Planning; Dementia Care Planning; Making Diagnosis; and Let's Talk About Sex

A total of 2,670 attended webinars, averaging 205 per webinar. Attendees are eligible to receive continuing education credits.

In addition, information was shared through a bi-monthly newsletter, email alerts and on the MGS website at www.mngero.org.
