Shipping: Medical equipment and supplies are gathered and shipped all over the world to Lutheran health care systems. In 2016, GHM shipped 9 sea containers in support of hospitals and clinics in six countries. Ninety-two groups of travelers hand carried medical supplies and equipment provided by our suitcase ministry to 28 different countries.

Capacity Building: We believe God is calling us to empower Lutheran healing ministries to become increasingly sustainable in countries deeply challenged by poverty. Our focus is on enhancing our international partners' capabilities to make measurable and sustainable improvements, both in healthcare and in population health. In five countries we supported training for health leaders at every level: from health administrators to doctors, nurses, lab technicians, midwives and village health workers. Our focus on the health of whole communities includes helping people take ownership over their own health while decreasing disparities in access to health care and healthy lifestyles.
