Our Anti-Violence Program provided support and solace to 1000+ survivors of hate and bias violence, intimate partner violence, and sexual violence. This work included providing emergency assistance for LGBTQ survivors, as well as support navigating the criminal justice and healthcare systems. Additionally, we have a monthly support group for survivors to assist in their healing journey. We won a lawsuit that struck down a discriminatory law that prohibited low-income trans people on Medical Assistance or Minnesota Care from having gender confirmation surgeries. We worked with several businesses to provide assistance in changing their health insurance policies to provide critical health care for transgender people. Engaged over 700 LGBTQ supporters in work to stop legislation repealing human rights act protections banning discrimination against trans people in education and public accommodations. Organized volunteers and funding through our PAC, to support candidates who have a commitment to advance LGBTQ and racial equity. In 2016, we trained over 4500 Minnesotans in workplaces, faith institutions, schools, organizations, government agencies and in communities on LGBTQ inclusion and equity. This work included the expansion of the number of middle school and high school Gender and Sexuality Alliances (GSAs) we work with from 85 to 127, a 34% increase. They have joined our GSA Network so that they can lead our youth work and we provide them with leadership training and support.
