PART VI, SECTION A, LINE 6: Membership in DTSF shall be available to any person or business which believes in & will promote the purposes and objectives of DTSF. Membership consists of three classes of members:

1. Business Memberships

2. Residential Memberships - open to individuals & families who live in the downtown Sioux Falls area.

3. Business Improvement District ("BID") Members - businesses who are required to pay an assessed tax to the City of Sioux Falls for the property they own within the boundaries of the Business Improvement District. This tax is mandatory. If the tax is not paid to the City of Sioux Falls within three months, it is then transferred to Minnehaha County for collection through the property owner's property tax. As BID funds are received from the BID property owners, the City of Sioux Falls transfers the money to DTSF for use in conducting the BID Board approved budgeted activities.

PART VI, SECTION A, LINE 7A: Each member shall be entitled to one vote per membership in the annual election of Directors.

PART VI, SECTION A, LINE 8B: Committees are advisory in nature only. Recommendations from the committees must be brought to the full Board for approval. No committees have the authority to act on behalf of the Board of Directors.

PART VI, SECTION B, LINE 11B: The President emails each Director a draft of the IRS 990 return prior to is filing, asking for their approval of the return.

PART VI, SECTION B, LINE 12C: DTSF's conflict of interest policy covers Board members, officers and committee members with governing board delegated powers. A request is made annually for Board members to disclose any potential conflict of interest and if so, implements the procedure for evaluating the issue or transaction involved. The Board member, officer or committee members with the conflict must refrain from voting.
