At the discretion of the Board of Directors or the Executive Committee, the President and Chief Executive Officer may also be delegated the responsibility for reviewing employee compensation arrangements other than those for his/her own compensation, and, in those cases, the term authorized body, as contained herein, shall refer to the President and Chief Executive Officer. Prior to making a determination on compensation arrangements subject to this policy, the authorized body shall obtain and rely on appropriate data as to comparability. Such data will assist the authorized body in determining whether the compensation arrangement is comparable to arrangements made by other for-profit and not-for-profit organizations for individuals in similar positions. The authorized body shall adequately and timely document the basis for its determination on compensation arrangements concurrently with making that determination. The documentation of the authorized body shall include the terms of the transaction and the date of its approval, the members of the authorized body present during the debate and vote on the transaction, the comparability data obtained and relied upon, the actions of any members of the authorized body having a conflict of interest, and documentation of the basis for the determination.
