During 2016, Youth Service International conducted social international social outreach projects in Guatemala and Peru. The Guatemala project involved making repairs to a building in the town square, as well as teaching English and Catholic catechism to young people in local villages. The Peru project involved making repairs to a building in the town square, as well as teaching English and Catholic catechism to young people in local villages. The Guatemala project had 12 participants and the Peru project had 20 participants.

An additional \$41,560 of donated services were provided for this program activity.
