Leadership Lab is a community leadership program providing participants the opportunity to learn about our community, think about their effect in our community and develop a personal plan for making a difference. Community panels, speakers and small group field work are used throughout the eight month program. One part-time coordinator manages the program. Future Philanthopist Program provides young people with opportunities to participate in a uniquely-adapted philanthropic experience. Area high school students apply for this two year program which turns juniors into grant makers and seniors into fundraisers. Program expenses cover the cost of meetings and other related costs.
