The vision of Koinonia House® National Ministries (KHNM) is to glorify God through the redemption of our neighbors in prison by the gospel of Jesus Christ and their continued discipleship out of prison, thus reducing the recidivism rate. Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.

MEET ME AT THE GATE®: Since 1997, KHNM has been working with churches, organizations, and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program is available. Since 2008, it has worked through its affiliate organization, Koinonia House of Wheaton (KHW), to provide Christian men coming from prison a residential family-home-based discipleship program. In 2016, KHNM assisted 25 individuals/families with re-entry issues, and four men resided at the KHW.

Average attendance at our weekly Radical Time Out (RTO) increased from 85 to 91. RTO is an evening of dinner, fellowship, prayer and worship, where everyone is welcome to experience the love and grace of Jesus Christ, regardless of color, class, culture, crisis, or crime. In 2016, RTO was the vehicle for a remarkable story of reconciliation. IN-PRISON MINISTRIES: In 2016, KHNM conducted Freedom God's Way events in 11 adult correctional centers for over 900 men in the Illinois Department of Corrections. These multi-day events focus on presenting the Gospel of Jesus Christ and preparing inmates for their return to society through practical Bible teaching, life skills, singing, story-telling, confession of sins, and communion. Christian literature and Bibles are distributed when allowed. Staff & volunteer teams ministered weekly in Cook and DuPage County Jails, and monthly at Stateville and Pontiac Correctional Centers.

In addition to regular ministry within Illinois, KHNM conducted special services in jails and prisons in IN, MN, NC, NV, TN, and WI. A highlight for 2016 is that connections made with local churches in IN and NV during these special one-time events resulted in the establishment these churches holding weekly Bible studies at their county jails.

GENERAL: Expenses in this category cover activities such as helping families of incarcerated individuals, educating the public on the need of people returning to society from prison, and ministering to donor families. In 2016, KHNM staff assisted 20 individuals and families through formal and informal advisory sessions. KHNM staff members also spoke/taught on 21 radio and TV programs on 12 stations broadcasting from 7 states; 28 services or small groups for 16 churches, 6 parachurch ministries, and 1 school in 5 states.
